Maximum group size is 44 people. Subject to availability and the Cableway being open on the day.

Function Venues

1. Indoor Venues

(i) The Bistro is situated in the same building where the cable car docks.

- This U-shaped venue has three private balconies: one that faces Lion's Head and the City bowl; one facing the mountain and the Twelve Apostles Mountain range; and the third faces Devil's Peak.
- This function area is ideally suited for cocktail-style, standing functions with its scattered barstool seating and optional low seating inside and the picnic table seating on the bigger balcony.
- Maximum capacity as a cocktail function venue is 120 people.
- Includes set up and breakdown, 3 hour allocation.
- Full Bistro: **R7500.00** – for the full venue, exclusively, max of 120 people.
- Bistro Bar: **R4500.00** - for the bar side of the venue only, max of 60 people.
- Bistro Balcony: **R2500.00** - for the balcony nearest the Bar, max of 30 people.
- Devil's Peak Section/Dassie Den: **R4500.00** – for this section only, max of 60 people.



(ii) The Summit Room is situated above the Bistro venue.

- This venue has two private balconies, one that faces Lion's Head and the City bowl; and the other balcony faces the mountain, the Twelve Apostles Mountain range and Devil's Peak.
- This function room is ideally suited for cocktail-style/standing functions with its scattered seating both inside and outside on the balconies.
- Maximum capacity as a cocktail function venue is 35 people.
- Includes set up and breakdown, 3 hour allocation.
- This venue can be used for meetings and conferences, with the maximum capacity for this being 16 delegates only.
- The conferencing rates are group size negotiable, a quotation will be provided upon request.
- Summit Room hire: **R2100.00**.



2. Outdoor Venues

(i) The Old Stone Balcony is an open-air area situated behind the 'Shop at the Top', opposite the Café.

- This balcony faces the Twelve Apostles Terrace Mountains and is a fantastic site for sunset cocktail functions.
- Optional picnic table seating on the balcony.
- Maximum capacity is 35 people, standing.
- Includes set up and breakdown, 3 hour allocation.
- Balcony hire: **R2500.00** for the first 20 people; R25.00 p/p thereafter.





(ii) The Twelve Apostles Terrace is an open-air area situated below the Table Mountain Café.

- This Terrace also faces the Twelve Apostle's Mountains and is ideally an area suited for early morning breakfast functions and evening cocktail functions.
- Maximum capacity is 400 people.
- This is a weather dependant area and if the Bistro (mentioned above) is already booked, you will have no indoor *rain plan* back-up alternative at the Cableway.
- A large section of this Terrace is specially cordoned off for your event and it is currently the only designated smoking area on the mountain.
- If you have a very large group, it is recommended that your group wear easily identifiable tags, lanyards or group badges.
- Red ropes and black metal poles are used to cordon off the food and drinks tables and the function group.
- This is a standing, outdoor venue and high chairs are not recommended due to the uneven ground surface.
- Includes set up and breakdown, 3 hour allocation.
- Terrace hire: **R3500.00** for the first 150 people; R25.00 p/p thereafter.

(iii) The City Side Viewing Deck (first viewing deck) is an open-air balcony situated to the left of the Upper Cable Station.

- This area is very near to the Bistro and is only 2 minute walk from the Upper Cable Station.
- As indicated on the Table Mountain Information Guide, this is the deck immediately AFTER the first viewing deck in the booklet.
- This sandstone walled deck has beautiful views of the city and is excellent venue choice for any time of the day.
- Deck hire: **R2000.00** for a maximum of 20 people.



(iv) The Sacred Circle Viewing Deck (third viewing deck) is an open-air balcony situated further on from the previously mentioned viewing deck.

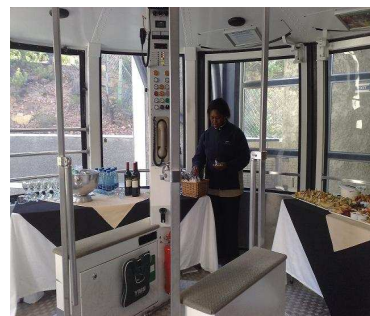
- This area is further away and is a 5 minute walk from the Upper Cable Station.
- As indicated on the Table Mountain Information Guide, this is the third and last wooden viewing deck facing the city side of the mountain.
- This wooden deck has equally beautiful views and is also suitable for any time of the day.
- Deck hire: **R3500.00** for a maximum of 30 people.

3. Capacity

- The maximum capacity of the venues is based on hosting cocktail-style functions, not seated functions.
- Venue hire includes: furniture, table linens, service equipment and service staff requirements.

4. We can offer you a Plan B

- We highly recommend our Plan B option at Level 5 (at the Lower Cableway Station, where you would board the cable cars) as your back-up venue, at no additional cost.
- This option is solely dependant on weather conditions on the day.
- Your group size and the time of your function will determine whether this back-up would be appropriate to your group or not.
- No shows at either venue will be charged in full.



5. Quotation Policy

- Prices are subject to change and all quotes are only valid 30 days.

6. Tickets

- 1 Oct 09 – 30 Sept 2010 - **R170.00** per adult return, purchased online.
- Purchased online, they are valid for 7 days.



7. Exclusive service

- One waiter is allocated per every 20 people, depending on the type of function.
- 10% gratuity charged on all food and beverage.
- This gratuity percentage is pre-invoiced on your function invoice prior to your function.

8. Catering

- All menus are halaal and in-house catering is served platter style, with the exception of seated functions.
- If your event is cancelled on the day due to poor weather conditions, the prepared food can be collected to be used at your Plan B venue, if it is someplace other than at the Cableway.

9. Drinks

- Fully licensed, drinks can be charged on consumption and the bar bill is to be settled prior to departure of the function area.



10. Incentive

- Miniature Table Mountain shaped bottles (125ml) filled with brandy/sherry/fruit schnapps/red grape juice/virgin olive oil, can be personalized or branded with your company logo or welcome message @ **R55.00** per bottle.

11. Payment

- Full payment of the function invoice is required 48 hours prior to the function (EFT preferred).
- Bank details are available on the initial invoice to you; please fax the payment remittance to: 021-424 3792 or e-mail it to taryn@tablemountain.net

12. Weather permitting

- Please know that the Cableway is a weather dependent function venue. Should the wind be too strong, the Cableway will need to close for safety reasons.
- In this instance there is currently no **INDOOR** Plan B venue available on site at the Cableway. Please bear this in mind when booking the venue.

13. Cancellation fee

- All cancellations, without exceptions, must be made in writing and proof of cancellation must be produced to claim a refund. All no shows will be charged in full.
- Please see attached *Terms & Conditions - this needs to be signed and sent back to secure your booking.
- In the event of the Cableway being closed due to strong wind and our Plan B option is not a viable option; a cancellation fee on the menu could be levied.
- Any special foods (oysters); drinks (Moët & Chandon) or arrangements (equipment hire) that are not usually catered for, will be charged in full regardless.
